# MICHAEL E. REILLY MEMORIAL PARK RENTAL AGREEMENT

## RULES AND REGULATIONS FOR FIREMAN'S PARK

### For Volunteer Fire Members

1. There will be A REFUNDABLE FEE OF \$200.00 **CASH ONLY** Deposit for the use of the park. Refund given if all equipment and park left clean and orderly. **No Exceptions!!**
2. There will be A NON-REFUNDABLE FEE OF \$300.00 charged to the lessee for the use of the park.
3. The lessee who signs this agreement shall be responsible for all facilities in the park, their guests and **Must** remain on site for the duration of the rental.
4. Gambling or games of chance of any type is **PROHIBITED.**
5. Consumption of alcohol is permitted must follow the New York State laws associated with alcohol (legal age and drinking and driving) see rule # 7
6. The sale of any liquor is **PROHIBITED.**
7. Any damage found to the main building, overhangs, any paved or cement areas, and all grass areas shall be the responsibility of the lessee.
8. It is expressly understood and agreed that the lessee shall hold the Incorporated Village of Patchogue, the Patchogue fire department, the Patchogue fire district its officials and employees harmless from any and all claims, suits, liabilities, causes of actions, damages, judgements, fines, penalties, and expenses attributable to personal injury or property damage incurred on, relating to or arising out of the lease of the Park, its facilities, equipment or parking lots by myself, my family, guests, agents, licenses, invitees or contractors. **An insurance certificate issued in my name holding the above parties harmless and in the amount of not less than \$2,000,000.00 shall be included as part of this agreement as submitted.**
9. Any lessee using amplified music, tents, bouncy house, slides, or any other piece of equipment not part of the Park must obtain the necessary permits from the Village of Patchogue and must submit insurance riders for such equipment to the Patchogue Fire District.
10. Lessee shall be responsible for the removal of all debris and or garbage at the end of the rental period. Any debris and or garbage found after the rental period may be removed at the lessee's expense and may prohibit the future use of the facilities.

11. The hours of operation of the park are from 8am to 10pm
12. The lessee should bring the following supplies as the Fire District will not supply the items
  - A) 20-pound propane tanks if using BBQ's
  - B) Toilet paper
  - C) Paper towels for kitchen and bathroom
  - D) Soap
  - E) Dish towels
  - F) Utensils for cooking and serving
  - G) Any party over 200 people lessees must have porta/lavatories at lessee expense
13. Inspection before and after of the facilities will be made by one of the representatives of the Fire District

**Any of the following rules that are not adhered to will result in the termination of the lease and party.**
